## **Overview of the Mobile Proof Testing Module**

The Mobile Proof Testing module allows you to manage Proof Tests without a network connection. Mobile proof testing enables the maintenance personnel to be offline (i.e., not connected to APM), and still execute test procedures and collect proof testing data using mobile devices such as a tablet. The Proof Test Data is synchronized automatically to the SIS Management module when you are online (i.e., connected to the APM).

## **Mobile Proof Testing Workflow**

This workflow provides the basic, high-level steps for using this module. The steps and links in this workflow do not necessarily reference every possible procedure.

- 1. Download a Proof Test Task for offline access.
- 2. Record the Proof Test Details for the Proof Test.
- 3. Create a Recommendation. You can also attach an image to the Recommendation.

The values that you recorded in the Proof Tests when you were offline are synchronized automatically to the APM database when you reconnect the mobile device to the network.

## **About Mobile Proof Tests**

You can use Mobile Proof Testing on the APM mobile application to run test procedures and collect proof testing data using mobile devices, such as a tablet. You can record values for the Proof Test and create recommendations (e.g., a maintenance follow-up) for the proof test, directly from the mobile device even if the mobile device is disconnected from the network.

When you download a Proof Test Task for offline access, on the **Mobile Proof Testing** page, the appears on the downloaded Proof Test Task, indicating that the Proof Test Task is downloaded to the mobile device that you will use for recording values for the Proof Test.

## **About Synchronizing Mobile Proof Tests**

When you reconnect the mobile device to the network, the values that you recorded in the Proof Tests and the Recommendations that you created are uploaded automatically to the APM database.

The color of the 🕑 icon that appears on the upper-right corner of the Proof Test in the **Mobile Proof** 

**Testing** page, indicates the status of synchronization. The 🕗 icon changes to one of the following:

- C: Indicates that the synchronization is completed successfully. The values that you recorded in the Proof Test and the associated Recommendations are uploaded to the database.
- (Indicates that the synchronization failed. When you select (), a message appears, describing the error that has caused the synchronization to fail. The error may be either in the Proof Test or in the Recommendation.

On successful synchronization, APM copies the values in the Proof Tests that you executed in the mobile device to the corresponding Proof Tests in the database. You can access these Proof Tests from the SIS Management module.

APM system creates copies of the Recommendations that you created in the mobile device, and then links them to the Instrumented Functions with which the Proof Test Tasks are associated. The images attached to the Recommendations that you created for the Proof Test appear as Reference Documents in the Recommendations created for the Instrumented Function.

Tip: For more information, refer to the Reference Documents section of the documentation.

### Access the Mobile Proof Testing Page

This topic describes how to access the Mobile Proof Testing page, also known as the Offline Store. The Mobile Proof Testing page contains the list of Proof Test Tasks that you downloaded for offline use.

#### **Before You Begin**

Download a Proof Test Task for offline access.

Note: Downloaded Proof Test Tasks are stored in the device's internal storage.

#### Procedure

In the module navigation menu, select Integrity > Mobile Proof Testing.

The Mobile Proof Testing page appears, displaying the list of proof test tasks that you downloaded.

## **Create a Proof Test Recommendation in Offline Mode**

#### **Before You Begin**

• Download a Proof Test Task for offline access for which you want to create a Proof Test Recommendation.

#### **About This Task**

During proof testing, if you observe an abnormality or failure that cannot be resolved immediately, you can create a Recommendation. You can also attach an image to the recommendation.

**Note:** You can create Recommendations for a Proof Test only if the Proof Test is executed using the Mobile Proof Testing module.

#### Procedure

- 1. Access the Proof Test Task for which you want to create a Recommendation in offline mode.
- 2. On the upper-right corner of the page, select

The Recommendation for the Proof Test is created.

#### Results

- The Recommendation that you created is listed in the **Recommendations** pane for the Proof Test.
- If there are two Proof Tests for the same Instrumented Function, then the Recommendation will appear in the list of Recommendations for both the Proof Tests.
- The Recommendation is synchronized automatically when you are online (i.e., connected to the APM), and will appear on the **Recommendations** pane of the Instrumented Function associated with the Proof Test for which you created the Recommendation.

## Attach an Image to the Recommendation

#### **Before You Begin**

• Create a Recommendation for a Proof Test in offline mode.

**Important:** To attach an image to the Recommendation, you must use the GE Digital APM mobile application. If you are using APM in a web browser, you cannot access the camera on your device.

#### Procedure

- 1. Using the GE Digital APM mobile application, access the Recommendation for which you want to attach an image in offline mode.
- 2. In the upper-left corner of the Recommendation datasheet, select  $\bigcirc$ .

The default camera application for your device appears.

3. Using the camera on your mobile device, take a picture of the asset whose image you want to attach to the Recommendation.

The captured image is attached to the Recommendation and appears as a thumbnail above the datasheet.

#### Note:

If you want to delete an image from the Recommendation:

a. In the upper-right corner of the image thumbnail, select imes .

The **Confirm Delete** dialog box, asking you to confirm that you want to delete the image.

b. Select **Yes**.

The image is deleted.

## Delete a Proof Test from the Offline Store

#### Procedure

- 1. Access the Mobile Proof Testing page.
- 2. In the right corner of the Proof Test that you want to delete, select  $\fbox{10}$ .

The **Confirm Delete** dialog box appears, asking you if you want to delete the Proof Test from the offline store.

3. Select Yes.

The selected Proof Test is deleted from the offline store.

#### Note:

- When you delete a Proof Test, the associated Proof Tests Details are also deleted from the offline store.
- When you delete a Proof Test from the offline store, the related Proof Test will still be available in the APM database. As needed, you can manually delete the Proof Test from the database.

#### Results

- If the Proof Test that you deleted was associated with a Recommendation, then the Recommendation and any image associated with the Recommendation are deleted from the offline store.
- If a Recommendation is associated with more than one Proof Test, and you deleted one of the Proof Test, then the Recommendation and associated images will not be deleted.

## **SIS Functional Test Detail Records**

This topic provides an alphabetical list and description of the fields that exist in the SIS Functional Test Detail family. When you apply a Proof Test Template to a Proof Test, a Functional Test Detail is created for each Proof Test Template Detail. The values in most of these fields are populated with the values in the corresponding fields in the related Proof Test Template Detail. This list is not comprehensive.

This family is enabled for site filtering, which means that records in this family can be assigned to a specific site, and will only be accessible to users who are assigned to the same site and have the appropriate license and family privileges. For more information, refer to the Sites section of the documentation.

Field	Data Type	Description	Behavior and Usage
As Found Travel Time	Numeric	The time taken by the Final Element to reach the safe state from its normal operating state. This value is measured in seconds.	This field is enabled only if the value in the Step Type field is Final Element. If the value in this field exceeds the value in the Travel Time Limit field, then the proof test step fails.
As Found Trip Point	Numeric	A number that defines when the element has activated an SIS shutdown.	This value is used to calculate the As Found Trip Point Error.

As Left Travel Time	Numeric	The time taken by the Final Element to reach the safe state from its normal operating state, after repairing the element. This value is measured in seconds.	This field is enabled only if the value in the Step Type field is Final Element.
As Left Trip Point	Numeric	A number that defines when the element has activated an SIS shutdown after repairing the element.	This value is used to calculate the As Left Trip Point Error.

As Left Trip Point Error	Numeric	The error value calculated for the value that you have entered in the As Left Trip Point field.	This value is disabled and calculated as follows: As Left Trip Point Error = [(As Left Trip Point - Trip Point) *100] / Trip Point

Equipment ID	Character	The ID of the Equipment against which the step is performed.	This field is disabled and populated with the value in the Equipment ID field in the corresponding Proof Test Template Detail.
Executed By	Character	The ID of the user who conducted the proof test.	This field is disabled and populated with the ID of the current user.
Execution Date	Date	The date on which the proof test was conducted.	This field is disabled and populated with the date and time on which the Functional Test Detail is saved.
Failure Condition	Character	The condition in which the proof test step failed.	None
Failure Type	Character	The type of the failure.	<ul> <li>This field contains the following values:</li> <li>Safe</li> <li>Dangerous</li> <li>No Effect</li> </ul>
Location ID	Character	The ID of the Functional Location against which the step is performed.	This field is disabled and populated with the value in the Location ID field in the corresponding Proof Test Template Detail.
Pass/Fail	Character	Indicates whether the proof test step has passed or failed based on the pass/fail criteria that you have specified in the corresponding Proof Test Template Detail.	This field contains the following values: • Pass • Fail • Skip • Complete
Result Criteria	Text	A description of what is considered to be an acceptable result of the step.	This field is disabled and populated with the value in the Result Criteria field in the corresponding Proof Test Template Detail.

Trip Point	Numeric	A number that defines when the element should activate an SIS shutdown.	This field is enabled only in SIS Proof Test Template Details that are linked to records representing sensors, final elements, or logic solvers.
Trip Point Direction	Character	The trend of Trip Point values.	This field is disabled and populated with the value in the Trip Point Direction field in the corresponding Proof Test Template Detail.
Trip Point Error Limit	Numeric	A value that defines the range, plus or minus, within which the Trip Point value must fall to be acceptable.	This field is disabled and populated with the value in the Trip Point Error Limit field in the corresponding Proof Test Template Detail.
Trip Point Units	Character	The unit of measure associated with the value in the Trip Point field.	This field is disabled and populated with the value in the Trip Point Units field in the corresponding Proof Test Template Detail.

## **Risk Assessment Recommendation Records**

Recommendation records store details about the recommendation that you have proposed to mitigate the risk. This topic provides an alphabetical list and description of the fields that exist for the Recommendation family. These fields appear on the Recommendation datasheet, unless otherwise specified. The information in this table reflects the baseline state and behavior of these fields. This list is not comprehensive.

This family is enabled for site filtering, which means that records in this family can be assigned to a specific site, and will only be accessible to users who are assigned to the same site and have the appropriate license and family privileges. For more information, refer to the Sites section of the documentation.
