## Enhancements - V4.1.0.0

The following enhancements have been made in V4.1.0.0.

## Asset Health Manager

- On the **Health Indicator Source Management** page, when you include or exclude sources, a notification now appears to indicate that the sources were included or excluded successfully. (TS ID: 160302)
- You no longer have to configure the values within the <meridiumConnections> tags in the AHM Service configuration file. Instead, this service now connects automatically to all valid data sources specified on the Meridium Enterprise APM Server. As a result of this change, you no longer have to modify the AHM Service configuration file before starting the service. (TS ID: 152368)
- You can now create Meridium General Recommendations based on events displayed on the **Health Summary** page. Recommendations that you create in this way are populated with information about the event and asset, as well as linked automatically to the related asset. (TS ID: 115014)

### **Asset Strategy Management**

- In the Actions workspace, **Risks** workspace, and **Implement Actions** workspace, the **Status** column now contains icons, instead of letters, to represent:
  - New Records
  - Deleted Records
  - Modified Records

## **Calibration Management**

- The Equipment ID field in a Calibration datasheet is no longer a required field. (TS ID: 61334)
- You can now select a Calibration Template on a Calibration Task datasheet. As a result of this enhancement, a new field, Calibration Template ID, has been added to the Calibration Task datasheet. (TS ID: 156143)

- In addition to the Fluke 74x documenting process calibrator, Meridium Enterprise APM now supports the Fluke 75x documenting process calibrator. You can now transfer calibration data between Meridium Enterprise APM and the Fluke 75x documenting process calibrator. (TS ID: 162185)
- Before you perform an automated calibration, you can now verify or modify the following calibrator settings from the **Settings** window:
  - Communication Port
  - Baud Rate
  - Service Port

You can also test the connection of the calibrator from the **Settings** window. If the connection fails, a message appears that specifies the reason or provides a link to download the Meridium Device Service as applicable.

#### Catalog

• When you delete a catalog item, a confirmation message now appears before the item is deleted. (TS ID: 155114)

#### **Configuration Manager**

• On the **Manage Translations** page, you can now view the list of translated strings that were not uploaded, and you can choose to send an email containing the translated strings to Meridium, Inc. (TS ID: 160467)

#### Dashboards

• You now have the option to include underlying queries and graphs when exporting dashboard. (TS ID: 74301)

#### Help System

• You must now log in to Meridium Enterprise APM to access the Meridium Enterprise APM help documentation. (TS ID: 166353)

#### Queries

• Multi-value parameters are now supported in URL parameters for queries. (TS ID: 163722)

## Hazards Analysis

- The Assets that are linked to a System/Node are now listed in a separate section called **Linked Assets**. You can add or remove Assets in this section. As a result of this enhancement, the Equipment ID and Functional Location ID fields have been removed from the System/Node datasheet. (TS ID: 167197)
- If you remove an Asset from a System/Node, the corresponding Asset Group is now also updated. You no longer need to remove the Asset manually from the Asset Group. (TS ID: 167197)

### **Inspection Management**

• Asset Groups can now be used with the **Inspection Management Overview** work-space. (TS ID: 154297)

## **Metrics and Scorecards**

- You can now view the Associated Pages in KPI and Scorecard. (TS ID: 170156)
- You can now set a Scorecard as your home page by selecting the option **Set as Home Page** on the Scorecard details page. (TS ID: 167617)
- You can now filter the KPIs that are associated with a Scorecard based on their performance. You can do this by using the hu button available on the KPI details page. (TS ID: 64765)
- You can now zoom in and out on a graph in a Metric View. (TS ID: 147694)
- You can now add the slicer member to a Metric View during the runtime. You can do this by using the hu button available on the **Metric View** page. (TS ID: 131318)

**Policy Designer** 

• You no longer have to configure the values within the <meridiumConnections> tags in the configuration files for the Policy Execution Service and Policy Trigger Service. Instead, these services now connect automatically to all valid data sources specified on the Meridium Enterprise APM Server.

In addition, the default value for the execution server address in the Policy Trigger Service has been changed to *localhost*.

As a result of these change, you no longer have to modify the Policy Execution Service configuration file before starting the service. In addition, if you have only one Meridium Enterprise APM Server in your system architecture, you no longer have to modify the Policy Trigger Service configuration file. If, however, your system architecture contains more than one Meridium Enterprise APM Server, you will still need to modify the Policy Trigger Service configuration file in order to specify the name of the load-balanced cluster that you want to use for policy execution.

 Previously, emails sent from policies via the Email Contact node were sent from the email address associated with the user defined in the MeridiumConnections section of the AHM Service configuration file. Now, emails sent from policies use the From address specified in the Email Settings section of Operations Manager. (TS ID: 164324)

#### **Process Data Integration**

• By default, OPC Readings are now excluded from the global search. (TS ID: 157285)

## **Production Loss Analysis**

• You can now specify the number of decimal places that appears for all the Monetary and Quantity fields in PLA. The values that are calculated by the Meridium Enterprise APM system will be displayed using the number of decimals defined in the **Settings** window on the **PLA Administrator** page.

When you upgrade from previous versions to V4.1.0.0, the precision value defined for the Cost of Losses field will be applied to all the monetary fields and the precision value defined for the Unaccounted Loss field will be applied to all the quantity fields.

## Rounds

• You can now edit Lubrication Management Routes using the **Route Management** page in Rounds Designer. When you upgrade from previous versions to V4.1.0.0, Lubrication Requirement schedules are now automatically upgraded to the format used in Meridium Enterprise APM V4.

**Note:** Lubrication Management Data Capture support remains limited to paperbased reports and data entry via Record Manager.

### SIS Management

- When you copy an Instrumented Function, the linked SIL Assessment record is also copied. If the linked SIL Assessment is *LOPA Internal*, then when you copy the Instrumented Function, the LOPA, Conditional Modifiers, and Independent Layers of Protection are also copied. However, the other SIL Assessment records that are associated (and not linked) with the Instrumented Function are *not* copied. (TS ID: 137180)
- The SIS Management Overview page has been changed as follows:
  - The three tabs, Sensors, Logic Solvers, and Final Elements, have been replaced by a single tab, Custom Failure Data. The Custom Failure Data section displays the information for all the three types of custom devices, allowing you to create a new one, or modify or delete an existing one.
  - A new tab, SIS Trip Reports, has been added. The SIS Trip Reports section displays a list of SIS Trip Reports, allowing you to create a new one, or modify or delete an existing one.

• The SIS Management module now uses exida's Safety Equipment Reliability Handbook (SERH) database version 2015.2.01. (TS ID: 174883)

## Resolved Issues - V4.1.0.0

The following issues existed in one or more previous releases and have been resolved in V4.1.0.0.

## **Asset Criticality Analysis**

- Previously, when you changed the ACA System Name and then added an Asset to the ACA system, the changes would not be updated. This issue has been resolved. (TS: 162395)
- Previously, for an asset, when you deleted the relationship to the Functional Location record from the **Asset Finder**, an error message did not appear. This issue has been resolved. (TS: 163844)
- Previously, when you created a new ACA Analysis or a new ACA system, the page changed after you selected **Save**. This issue has been resolved. (TS: 170081)
- Previously, when you viewed the **Analysis Overview Graph** in the **Risk** section of an **ACA**, if you selected the grid view, the **Show Legend** and **Show Label** options were available. This issue has been resolved. Now, in the grid view, the **Show Legend** and **Show Label** options are disabled. (TS ID: 127719)

## Asset Health Manager

- Previously, an issue intermittently occurred in which the user credentials specified in the AHM Service configuration (Meridium.AHI.Service.exe.config) file could not be retrieved and therefore the service failed to connect to the corresponding data source. When this happened, Health Indicator records were not updated or created as expected. In addition, on the Meridium Enterprise APM Server, this issue caused the AHM Service log files (Meridium.AHI.Service<Timestamp>.log) to grow rapidly as numerous entries were added. This issue has been resolved. (TS ID: 159771)
- Previously, if you deleted a Health Indicator record in Record Manager, and this was the only Health Indicator record related to a particular source, the source was still marked as *included* in the list on the **Health Indicator Source Management** page. This issue has been resolved. Now, if the only Health Indicator related to a source is deleted, the source is marked automatically as *excluded*. Note that no notification regarding the exclusion is displayed to the user in this scenario. (TS ID: 160686)

- Previously, the **Policies** section of the **Health Summary** page did not show any values in the **Last Execution** column. This issue has been resolved. (TS ID: 165380)
- Previously, the **Health Indicator Status by Asset** graph on the **Health Overview** page did not show the correct number of health indicators for each asset. This issue has been resolved. (TS ID: 166137)
- Previously, if you acknowledged a health indicator status until a certain date, the current local time of the server was incorrectly used instead of UTC time to determine whether or not the expiration date had passed. This may have resulted in the acknowledgment expiring either earlier or later than expected. This issue has been resolved. (TS ID: 162726)
- Previously, if a reading record associated with a health indicator source record was deleted, the corresponding health indicator(s) were not updated correctly throughout Asset Health Manager. This issue has been resolved. Now, when a reading record is deleted, any corresponding health indicators will be updated to reflect the latest reading record that exists in the database. (TS ID: 61170)

## Foundation

#### **Asset Hierarchy**

• Previously, when you added the Meridium, Inc. assets in Asset Groups, all 1256 assets would be added to your database, and you were able to add them more than once, duplicating them in your database. This issue has been resolved. You can now only add these assets to a group once. (TS ID: 159714)

#### Meridium Enterprise APM Mobile Application

• Previously, when you selected a hyperlink in the Meridium Enterprise APM mobile application, the link would not open in your device's browser. This issue has been resolved. Now, when you select a hyperlink, the link opens in your device's preferred browser. (TS ID: 161737)

#### Catalog

• Previously, when you opened a query in the Catalog, the **Open** button may have remained enabled after you navigated away from a selected query. This issue has been resolved. (TS ID: 101893)

- Previously, when deleting a Catalog folder, you were not notified that folder contents would also be deleted. This issue has been resolved. (TS ID: 120912)
- Previously, an error occurred when you created a new folder in the Catalog. This issue has been resolved. (TS ID: 130472)
- Previously, when you created a new folder in the Catalog, that folder was not highlighted automatically in the Catalog after it was saved. This issue has been resolved. (TS ID: 139105)
- Previously, when you saved an item in the Catalog, the Name and Caption fields were not required fields. This issue has been resolved. (TS ID: 139997)
- Previously, when you searched for an existing catalog item, the button normally selected to create a new Catalog item appeared in the left pane. This issue has been resolved. (TS ID: 155811)
- Previously, when viewing Catalog items, selecting the check box in the grid heading did not select all of the items in the grid. This issue has been resolved. (TS ID: 172815)
- Previously, retrieving a Catalog item with a space at the end of its path string from an Oracle database would return a null value. This issue has been resolved. (TS ID: 173128)

#### **Configuration Manager**

• Previously, when you uploaded translations containing place holders in a translated string, an error occurred that would halt the Manage Translation feature of Configuration Manager. This issue has been resolved. The translated strings will be uploaded as expected, and the strings that were not uploaded will appear in the **Upload Custom Translations** window. (TS ID: 160464)

#### Dashboards

• Previously, when you created a new dashboard, left it empty, and switched between the dashboard and another tab, the new empty dashboard may have appeared with the Edit Mode disabled. This issue has been resolved. Now, the Edit Mode is always enabled for dashboards that are empty. (TS ID: 162708)

- Previously, when you applied a filter query to a dashboard and then tried to remove the filter query in Edit Mode, an error message appeared when you tried to view the dashboard. This issue has been resolved. (TS ID: 159874)
- Previously, on Android devices, when you attempted to add a Hyperlink widget to a dashboard, the Android device's keyboard would obscure portions of the screen so that you could not complete the widget properly. This issue has been resolved. (TS ID: 163085)

#### Datasets

• Previously, the tab name for a dataset page displayed the value in the dataset's Name field rather than the Caption field. This issue has been resolved. Now, the page for a selected dataset displays the value in the dataset's Caption field as the tab label for that page. (TS ID: 145330)

#### **Datasheet Builder**

- Previously, whenever you closed a **Datasheet Dialog** box, an error message appeared. This issue has been resolved. (TS ID: 90228)
- Previously, whenever you changed the Short Date Format Set in the field behaviour for datasheets, the datasheet did not load and an error message appeared. This issue has been resolved. (TS ID: 156118)
- Previously, whenever you changed the fields in a Datasheet Builder and saved the datasheet, the Last Updated Date did not update to reflect the change in the **Data Information** page. This issue has been resolved. (TS ID: 159584)
- Previously, if an error appeared while closing a datasheet, and you then closed the error message, a spinner appeared on the datasheet and the page would stop responding. This issue has been resolved. (TS ID: 156893)
- Previously, on iOS devices, if you opened a family in Datasheet Builder, you could not scroll through the available items for that family. This issue has been resolved. (TS ID: 147497, 151350)
- Previously, when you opened the Datasheet Builder, the Field names in a Datasheet Builder were localized. This issue has been resolved. (TS ID: 157412)

- Previously, on iOS devices, whenever working with datasheets, scrolling was not smooth if you dragged from the fields or were working with a Result grid. This issue has been resolved. (TS ID: 156360)
- Previously, when you searched for a datasheet and attempted to select the hyperlink for the record that you want to open, you could not select the hyperlink if the page is not in edit mode. This issue has been resolved. (TS ID: 147008)
- Previously, when you edited the value on the datasheet for a Route or an ML, an MLTG or an MLT, and then selected save, the value did not save or update. This issue has been resolved. (TS ID: 167888)
- Previously, when you opened a Functional Location record, copied, and then pasted the reference document path, an error message appeared and the document path was not pasted. This issue has been resolved. (TS ID: 156882)
- Previously, when you created a record for family in **Family Management**, if you skipped a few required fields and saved the datasheet, the authentication dialog box appeared. This issue has been resolved. (TS ID: 169404)
- Previously, in bulk datasheet, when you switched from a functional location description cell to the next cell, and then selected **Cancel** button in the text editor, an exception error message appeared. This issue has been resolved. (TS ID: 167741)

#### **Date Sources**

- Previously, when you modified a new or existing data source and did not save the changes, if you navigated away from the page, no notification message was displayed to indicate that the modifications to the data source would be lost was displayed. This issue has been resolved. An appropriate message is now displayed in this scenario. (TS ID: 139083, 142939)
- Previously, on tablet devices, when creating a new data source, the part of the data source form was inaccessible. This issue has been resolved. (TS ID: 151504)
- Previously, in Security Manager, changes made to the data permissions for a family would not appear to other users until Redis was restarted. This issue has been resolved. (TS ID: 153503)
- Previously, in Operations Manager, configuring email settings via SMTP caused

data source values to change unexpectedly. This issue has been resolved. (TS ID: 166573)

#### Date Time Control

• Previously, on iOS devices, in the Date Time Control, when you selected the top half of the month arrow, the date widget would close. This issue has been resolved. (TS ID: 155610)

#### **Global Search**

• Previously, the Global Search index rebuild would not apply the rebuild to all servers in a multi-server setup, but would only apply it to a single server. This issue has been resolved. (TS ID: 160405)

#### Graphs

- Previously, when you made settings changes to axis gridlines in Graphs, you could not save your changes. This issue has been resolved. (TS ID: 156799)
- Previously, when you selected the Stacked Percent check box in the Settings menu in Graphs, the graph did not utilize the full range of the vertical axis. This issue has been resolved. (TS ID: 142034)
- Previously, when you accessed a graph and changed the Axis to Bottom Axis in the Series section of Settings, you received an error message stating that the graph could not be drawn. This issue has been resolved. (TS ID: 163097)
- Previously, when you attempted to access a graph or chart that did not exist, a blank screen would be displayed. This issue has been resolved. Now, when you access a graph or chart that does not exist, you will receive an error message. (TS ID: 145918)
- Previously, in graphs, if you had a hyperlink set somewhere on the page, then you would see the hyperlink cursor regardless of where your cursor hovered on that page. This issue has been resolved. (TS ID: 167054)
- Previously, in Graphs, when you viewed the Cumulative Failures Plot in Reliability Growth and selected the Labels button, the labels would obscure the plot, making it mostly unreadable. Also, if you zoomed in on a section of the plot and then selected the Labels button, the zoom was reset. This issue has been resolved. (TS

ID: 126124)

#### Login

• Previously, on the Meridium Enterprise APM login screen, when you changed the Meridium Enterprise APM Server name, the data sources pertaining to the previously selected Meridium Enterprise APM Server were not cleared from the data source list. This issue has been resolved. Now, when you change the Meridium Enterprise APM Server, the data sources pertaining to the previous server are cleared from the data sources list and the data sources for the newly selected server are loaded. (TS ID: 163084)

#### Query

- Previously, in update queries, expressions entered in the Update To field would not be retained in the expression builder if it was reopened. This issue has been resolved. (TS ID: 99842)
- Previously, in append queries, an unnecessary **Target Source** link appeared in the **SQL** section of the query's workspace. This issue has been resolved. (TS ID: 99843)
- Previously, in delete queries, an error occurred when you selected a relationship family as a target source. This issue has been resolved. (TS ID: 101912)
- Previously, when you selected the option to update or delete a query, the resulting confirmation windows lacked titles. This issue has been resolved. (TS ID: 151643, 146706)
- Previously, the Query Builder allowed you to enter a prompt ID containing a space, though the presence of a space would cause the query to fail. This issue has been resolved. Now, if the user enters a prompt ID containing a space, a message indicating that the prompt ID cannot have spaces will appear. (TS ID: 151669)
- Previously, on Android devices, an error occurred when you added a related source in a query. This issue has been resolved. (TS ID: 159474)


The following new features are available in V4.1.7.0:

#### Foundation

Site Filtering is a new feature in V4.1.7.0 designed to help users who are assigned to specific sites find relevant records more easily. Site Filtering is a useful tool for companies that have facilities at multiple sites because users are prevented from viewing records associated with sites to which they are not assigned.

Starting in V4.1.7.0, Site Filtering is not an optional configuration in Meridium Enterprise APM. Most baseline entity families in Meridium Enterprise APM will have site filtering enabled by default, however, certain families will not be enabled for site filtering, which means that records in these families are available to users assigned to any site.

On the families enabled for site filtering, a Site Reference Key is used to identify the site with which a record is associated. In the following image, you can see that entity families are related to a Site Reference via the MI\_SITE\_KEY system field. Each Site Reference is related to a Risk Matrix by the Has Risk Matrix relationship family.



Refer to the End User help for further explanations of the terms and concepts regarding Site Filtering, as well as details about how Site Filtering impacts specific modules. Refer to the Installation and Upgrade help for details about how users and records will be assigned to sites when you upgrade to V4.1.7.0.

#### Notes:

- Site Filtering is not a security feature. While Site Filtering can limit the number of
  results shown, it should not be considered a measure to block data access to certain users. Site Filtering improves the performance of Meridium Enterprise APM
  so that the data shown is curated specifically to the data that is most useful and
  necessary for your needs.
- Site Filtering replaces the Has Site Reference relationship and data filtering using family filters that were features of V3.
- The following enhancements to the Site Filtering feature will be provided in future releases:
  - The ability to transport records between sites in bulk.
  - The ability to create view-only sites.
  - The ability to filter state management by sites.
